## **Abstract Submission Details:**

To submit an abstract, click [here](#)!

**Title of Abstract:** No longer than 125 characters, punctuation marks (no quotation marks, please), and spaces. Make it simple and factual.

**Body of Abstract:** You may enter the text directly or create the abstract in Microsoft Word or comparable software, then copy and paste. No graphs or figures or pictures are allowed. THERE IS A MAXIMUM LENGTH OF 300 WORDS.

**Topic Category:** Choose the single, most appropriate topic category from the drop down list. Program Committee members will be reviewing all abstracts. Where appropriate, abstracts may be shifted to other topic categories for programming the meeting.

**Preference for presentation type:** Please indicate a preference for oral versus poster presentation. **BUT PLEASE NOTE:** due to the limited amount of space on the meeting program for oral presentations, most submitted abstracts will be presented as posters. Author preferences will be considered, however, final decisions on the presentation type will be made by Program Committee members following the review of all submitted abstracts.

**Deadline for submission is March 7th, 2017 at 11:59 PM EST.**

## **Travel Awards:**

Presenting Authors who are trainees may apply for one of several travel awards to be granted by organizers of the American Association of Neuropathologists.

There are **6 travel awards for trainees** (available to any trainee enrolled in an accredited ACGME training program who is an author on an abstract submitted to the AANP annual meeting), as well as **4 ISN travel awards** (available to any neuropathologists/ neuroscientists under the age of 40 from low-middle income country who is an author on an abstract submitted to the AANP annual meeting).

Eligible trainees include individuals who are part of a degree granting program (undergraduate or graduate), postdoctoral fellows, and individuals who are part of a clinical training program including medical students, residents and fellows. Individuals who do not fulfill these criteria need to include a description of their trainee status as part of the required mentor's letter of support. These cases will be assessed on a case by case basis to determine whether they should be considered eligible for a Trainee Travel Award.

If you'd like to be considered for one of these awards, go to the Abstract Information Tab to apply (in the Abstract Submission site). A letter of support that verifies the training status from the mentor/supervisor must be uploaded in order to complete your submission. The letter should be addressed to The AANP Program Committee. The letter should confirm that the applicant is a trainee and the reason why the letter writer thinks the applicant is suitable for the award.

## **Other Important Information:**

**Cancellation Policy:** Full Refunds, less \$25.00 US processing fee per registrant, will be granted to cancellations received in writing prior to May 19, 2017. No refunds will be granted after this date. Allow 6 weeks following the close of the meeting for refunds to be processed. Refunds will not be given to registrants who do not attend without prior cancellation notice.
