Staff Clinician (HS) in Neuropathology**

The National Institute of Neurological Disorders and Stroke (NINDS) of the National Institutes of Health (NIH) is seeking an outstanding neuropathologist to serve as a Staff Clinician (HS) and head of the Neuropathology Unit within the Surgical Neurology Branch in the Division of Intramural Research. Staff Clinicians in NINDS conduct basic, translational, and clinical research, provide care for patients at the NIH Clinical Center, train junior investigators, and collaborate within NINDS and across other institutes. Staff Clinicians can have a wide range of responsibilities relating to oversight of a clinical intramural research program. The Staff Clinician who will lead the Neuropathology Unit in the Surgical Neurology Branch will be responsible for providing clinical care and consultation on patients who require clinical assessment by neuropathology, and for a mentored research effort related to the clinical neurosciences and to neuropathology. Duties include development of laboratory and/or clinical research protocols, oversight and coordination of the Surgical Neurology Branch human brain sample tissue bank, collaborative research efforts with investigators in the Surgical Neurology Branch and across NINDS, mentorship and education of trainees, data analysis and evaluation, and publication of results. Clinical activities will be conducted in coordination with the Laboratory of Pathology (NIH-NCI), with access to state-of-the-art diagnostic tools for surgical neuropathology, including molecular testing and tumor methylation profiling.

The successful candidates must be an M.D./D.O. or M.D./Ph.D.; be a board-certified or board-eligible neuropathologist with relevant training in clinical care and research; hold a permanent, full, and unrestricted license to practice medicine in a state, the District of Columbia, the Commonwealth of Puerto Rico, or a territory of the United States; and meet the requirements to be clinically credentialed at the NIH Clinical Center.

Salary will be commensurate with experience. A full civil service package of benefits (including retirement, health, life and long-term care insurance, Thrift Savings Plan, etc.) is available.

Please include in your curriculum vitae (CV) a description of your mentoring and outreach activities, especially those involving women and persons from racial/ethnic or other groups that are underrepresented in biomedical research.
