## BALLOT ENCLOSED... *PLEASE VOTE!*

At the recent Chicago Meeting, the possibility of linking our annual meeting with that of the American Neurological Association (ANA) was discussed. A proposal to survey AANP members to determine the level of interest was approved by the Executive Council and the general membership. In September, every AANP member with a valid email address was sent a [Survey to Assess the Desirability of Linking the Annual Meetings](#). Of the total 622 emails sent, 63 were rejected because incomplete or inaccurate addresses, and of the 559 messages successfully delivered, 264 members (40%) responded as follows:

Although these data indicate generally favorable interest in linking the meetings (i.e., 66% positive vs. 18% negative), there was concern that they may not be reflective of the wishes of the general membership and that a more complete voting was warranted. Accordingly, included with this mailing, is a detachable ballot for all members, including those who responded to the earlier email survey.

Please complete and return the enclosed ballot to the Secretary-Treasurer **no later than January 15, 2002**. Since linking the meetings has significant implications, please review the background and the PROS and CONS before you vote. Your vote is anonymous, so please do not write on the ballot, but complete the requested information and sign the envelope so that we can verify your vote. After verification, the outer envelope will be destroyed and only the ballot retained for counting.

## DUES "R" DUE!

### *Save Time, Renew Online!*

Annual dues for 2002 will remain \$165, \$155 and \$140 for active, associate and affiliate members, respectively. Membership at all levels includes a personal subscription to the Journal of Neuropathology and Experimental Neurology.

While AANP mailings and copies of the JNEN are sent to US members by relatively economical bulk mail, postal regulations require that mailings to Canadian and overseas addresses be sent by First Class Mail. Although postage surcharges for members residing outside of the US were increased last year, the cost for overseas members were underestimated. Accordingly, as approved at the annual meeting, the postage surcharge for members outside of North America will be increased to \$40 per year. The postage surcharge for Canadian members will remain \$16 per year.

Dues notices/ membership renewal forms for 2002 have been mailed previously. This year members may renew their membership online—this should be particularly attractive to members residing outside of the US and those paying by credit card. **Deadline for receipt of payment of dues is January 31, 2002.** Members who have not paid by this date will **NOT** be eligible for abstract acceptance, JNEN, listing in the Directory or Association mailings. If you have not received your dues notice, or if you believe that yours is inaccurate, please contact the Secretary-Treasurer as soon as possible.

## STATE OF THE FOUNDATION

As a tax-exempt non-profit 501(c) organization, the AANP is able to accept charitable (tax-deductible) contributions. Since IRS regulations governing tax-exempt organizations (as the AANP) require that contributions be strictly separated from other operating income/ expenditures, it was suggested that a "Foundation" be established as the receiving arm of contributions to the organization. Our legal advisors are in the process of examining basic AANP corporate documents to determine if such a Foundation is indeed needed.

Although the AANP currently can accept contributions, before any active solicitations can be made (including sending letters, or placing a "contribution line" on our membership renewal forms), we are required to register in most states in which solicitations would be made. To complicate issues, each state has different regulations, fees, schedules, etc., regarding registrations. This process potentially also could become quite costly, as well as placing additional burden on the already stretched Secretary-Treasurer office. Several issues require further clarification before proceeding. Any thoughts or comments you might have can be directed to the Secretary-Treasurer.

## 2001 MEETING HIGHLIGHTS

**Business Meeting** - Minutes enclosed.

**Diagnostic Slide Session** - Case summaries and discussions enclosed.

### Highlights of the Chicago Meeting

The Seventy-seventh Annual Meeting of the American Association of Neuropathologists was held at the Mart Plaza Hotel in Chicago, Illinois from June 21-24, 2001.

The successful **Special Course**, *Developmental Neurobiology*, organized by President Stephen J. DeArmond, was held on Thursday, June 21, 2001 and attended by 236 registrants. Lecturers at the course included AANP members Drs. Jeffrey A. Golden, Eric Huang and Harvey B. Sarnat, and guests Drs. Thomas Curran, Louis F. Reichardt, Li-Huei Tsai, and Dennis D. O'Leary.

Drs. John J. Kepes and Harry de F. Webster were honored as recipients of the **2001 Meritorious Service Awards to Neuropathology**. The awards were presented by Drs. Richard L. Davis and J. Richard Baringer; texts of their introductions are included in this mailing.

Professor Paul Kleihues presented the **Saul Korey Lecture** on Saturday, June 23. His lecture, *Molecular Biology of Brain Tumors*, was extremely informative and provided an up-to-date review of this important topic.

The ever popular Saturday evening **Diagnostic Slide Session** featured 10 challenging and interesting cases accompanied by enjoyable and spirited discussions.

The **Presidential Symposium**, held Sunday morning June 24, included the Presidential Address by Dr. DeArmond, *Mechanisms of Degeneration in Prion Diseases*. Dr. Dennis W. Choi presented the **Matthew T. Moore Distinguished Lecture**, *Ischemia-induced Perturbations in Neuronal Ionic Homeostasis*. Other lecturers in the Presidential Symposium were Drs. Ralph A. Nixon and Cheryl Wellington, who discussed *Lysosomal Mechanisms of Neurodegeneration*, and *Huntingtin: A Fulcrum between Life and Death*, respectively.

At the **Scientific Sessions**, 223 abstracts were presented, including 93 platform and 130 posters.

**Awards** for best papers of 2001 were presented by Awards Committee Chair, Dr. George Perry, at the Sunday morning Presidential Symposium.

The **Moore Award** for the best paper on clinicopathological correlation was presented to R. Vidal, M.D. Benson, J. J. Liepnieks, M. Yazaki, L. Miravalle, E. Uro-Coste, M. B. Delisle and B. Ghetti for their presentation,

*A Neurodegenerative Disease with Intranuclear Protein Deposits: Electron Microscopic and Biochemical Studies*. (Abstract #47). S. Love and H. B. Coakham received Honorable Mention for the Moore Award for their paper, *Trigeminal Neuralgia Usually Results from Juxtaposition of Demyelinated Trigeminal Sensory Fibers*. (Abstract # 15).

The **Weil Award** for the best paper in experimental neuropathology was awarded to S. A. Moore, F. Saito, M. Henry, A. Messing, R. D. Cohn, R. Williamson, and K. P. Campbell for their paper, *Selective Deletion of Brain Dystroglycan Results in Neuronal Migration Errors* (Abstract # 38). Honorable Mention for the Weil Award was given to I. A. Scarisbrick, C. F. Lucchinetti and M. Rodriguez for their presentation, *A Trypsin-like Serine Protease Abundantly Expressed in the Adult Central Nervous System: Changes in MS Lesions* (Abstract # 12). Winners of the **Rubinstein Award** for the best paper in neuro-oncology were H. Ohgaki, M. Nakamura, T. Watanabe and P. Kleihues for their presentation *Promoter Hypermethylation of O<sup>6</sup>-Methylguanine-DNA Methyltransferase Gene in Gliomas* (Abstract # 126). Honorable Mention of the Rubinstein Award was awarded to K. A. Roth, B. J. Klocke and J. R. Leonard, for their paper *Enu-induced Neural Precursor Cell Apoptosis and Glial Tumorigenesis* (Abstract # 138).

The **Annual Reception** was held Friday evening June 22, at the Top of the Tower on the 99th floor of the Sears Tower. Meeting registrants and guests were treated to breathtaking views of the Chicago skyline while enjoying drinks, hors d'oeuvres and pasta bar selections. Reception prizes included books provided by Harcourt Health Sciences, awarded to Peter Lantos; Oxford University Press, awarded to Mrs. James E. McLaughlin; and IARC (International Agency for Research on Cancer), courtesy of Dr Paul Kleihues, awarded to Eun-Sook (Lucy) Cho, Pedro Piccardo, and Tarik Tihan.
