### Denver, CO — June 20-23, 2002

The Mile High City of Denver will host the 78th Annual Meeting of the American Association of Neuropathologists (AANP), June 20-23, 2002.

### NEW for 2002...PowerPoint Presentations

This year presenters at all Educational and Scientific Sessions will have the option of using computer-generated or conventional 35mm slide presentations. Single-screen PowerPoint projection will be offered. The AANP will supply all computer equipment used during the meeting. Computers will be equipped with Microsoft PowerPoint software (Office 2000) for PC/Windows and Mac.

### VOTES are IN...No hanging chads

The results of the paper ballot vote regarding interest in linking our annual meeting with that of the ANA are in. Of the 826 ballots sent, 197 were returned. The number returned was smaller than that from the preliminary email vote in August, but the results are similar, with the majority (2:1) supporting a joint meeting. The actual votes received were 134 in Favor and 63 Against. Although the number of ballots returned was disappointing, the experiment with the earlier email ballots suggests that we can communicate with the membership as effectively by email as by regular mail. Based on these results, discussions with the ANA are moving forward for future joint meetings.

### **HOTEL RESERVATIONS**

### **Scientific Sessions (Fri-Sat, June 21-22)**

Concurrent platform and poster sessions will be held all day Friday and Saturday, June 21 and 22, 2002. Up-to-date developments in all areas of experimental, research and practical neuropathology will be featured. Poster sessions will run from 8:00 am to 5:30 pm. Although no poster discussion sessions will be held, poster presenters will be asked to be present at designated times to facilitate discussion with other interested attendees.

This year, platform presenters will have the option of using either computer (PowerPoint) or conventional 35mm slides. Presenters are asked to bring their presentation on either a PC or Mac-formatted Zip disk or CD-ROM, as well as their laptops as backup. Our audiovisual provider will bring a show computer loaded with MS Office 2000 that will run from the podium, as well as zip CD-ROM drives. Presenters **must** bring their presentations on CD-ROM or Zip disk to the AV Preview Room from 7-9 pm on the evening preceding their talk for loading onto the show computer. Presenters at the morning sessions are asked to be present from 7-8 pm and presenters at afternoon sessions from 8-9 pm.

### **Presidential Symposium:**

#### ***Parkinsonism and Neuropathology (Sun, June 23)***

A symposium focusing on recent advances in parkinsonism has been organized by President Dennis Dickson. The program will feature Dr. Dickson's Presidential Address, *Neuropathology of Parkinsonism*, as well as lectures by Dr. Irene Litvan (Director of Cognitive Neuropharmacology Unit, Henry M. Jackson Foundation, Bethesda, MD) on *Parkinsonism: Clinicopathologic studies of Progressive Supranuclear Palsy (PSP) and Corticobasal Degeneration (CBD)*, and Dr. Matthew Farrer (Associate Professor, Mayo Clinic Jacksonville) on the *Genetics of Parkinson's Disease*. As part of the Symposium, the **Matthew T. Moore Distinguished Lecture, MPTP and Parkinsonism**, will be presented by Dr. William Langston, Founder and President, The Parkinson Institute (Sunnyvale, CA).

## Annual Reception: Colorado History Museum (Friday evening, June 21)

We are pleased to announce that the annual reception for meeting attendees and their guests will be held 6:30-8:30 pm Friday, June 21, at the Colorado History Museum, 1300 Broadway, Denver, CO 80203. The reception will occur at several locations within the Museum (Museum Level, First Floor Lobby and Boettcher Auditorium) and will include admission to the Exhibits on each floor. Hot and cold hors d'oeuvres and a cash bar will be available. A ticket for admission is included with each meeting registration. Additional tickets for guests of meeting attendees may be purchased for \$20 each for faculty/staff and \$10 each for students/ residents/ fellows. "Continuous" round-trip shuttle bus transportation between the hotel and the museum (5 minutes each way) will be provided from 6-9 pm.

Members and their guests will have the opportunity to discover the diversity of Colorado from its earliest inhabitants to its pioneer families, and to explore the museum's fascinating collections, detailed dioramas, historic photographs, artifacts, and more. Imagine covered wagons, fur trappers, Indian buffalo hunts, mining the Rocky Mountains, and life in early Denver.

Constructed in 1977, the museum preserves a collection of historic and prehistoric artifacts and documents and is the Colorado Historical Society's headquarters. In addition to exhibits and educational programs, the museum includes the Stephen H. Hart Library, the Office of Archaeology and Historic Preservation and membership services. The museum overlooks Denver's Civic Center with a view of the State Capital Building and other downtown landmarks. A museum store offers a full selection of books on Colorado and the West as well as a unique selection of Indian arts and Colorado crafts.

Current Exhibitions of the Colorado History Museum include:

**High Stakes Preservation:** An interactive exhibit exploring some of the 2,000 preservation projects made possible by funds from limited stakes gambling in three of Colorado's National Historic Landmark communities.

**Cheyenne Dog Soldiers:** The story of an elite corps of Cheyenne warriors and artists told through the events surrounding the Sand Creek Massacre and their later defeat at Summit Springs.

**La Gente:** The story of the Hispano people in Colorado.

**Colorado's Window to the Past:** Selections from the Society's collections.

**The H. A. W. Tabor Collection:** Portraits and artifacts relating to the fortunes and career of one of Colorado's most famous, and infamous, citizens.

**Comin' Up in Colorado: Images of Childhood from the State's First Half Century:** A child's eye perspective told through photographs and artifacts.

**The Colorado Chronicle: 150 Years of History:** A visual timeline of the State's history through 1949.

### **Destination DENVER**

Located at the foothills of the Rocky Mountains, Denver offers a wide variety of shops, department stores, restaurants, nightlife, and more.

Denver's buildings jut jaggedly into the skyline, creating an incongruous setting in a state that prides itself on its pristine wilderness. The last two decades have brought an influx of young, well-educated professionals lured by Colorado's outdoor mystique and encouraged by the area's business prospects. Denver is a city of cherished neighborhoods that extends a feeling of community throughout the city and makes it a particularly interesting place to explore. Most Denverites are unabashed nature lovers whose weekends are spent skiing, camping, hiking, biking, or fishing. (Perhaps as a result of this active life-style, Denver is the *thinnest* city in the United States, with less than 20% of the adult population overweight.) Areas such as LoDo—the historic lower downtown—buzz with jazz clubs, restaurants, and art galleries housed in carefully restored century-old buildings. The culturally diverse populace avidly supports the Denver Art Museum, the Museum of Natural History, the Colorado History Museum, and the Museo de las Americas. The expert acting troupe of the Denver Center Theater Company is at home in both traditional mountings of classics and more provocative contemporary works. An excellent public transportation system, including a develop-

ing light rail and 400 miles of bike paths, make getting around easy.

First-time visitors to Denver may be in for a few big surprises. Although best known as the "Mile High City," Denver also is the "Queen City of the Plains." Denver is flat, with the Rocky Mountains as a backdrop; this combination keeps the climate delightfully mild. Denverites take advantage of a comfortable climate (over 300 days of sunshine a year), historic city blocks, a cultural center (the Denver Performing Arts Complex is the nation's second largest with eight theaters seating over 9,000), and sky's-the-limit outdoor adventures just minutes from downtown.

On your visit, plan to explore downtown Denver:

#### ***Stroll through Civic Center Park***

This four-square block park offers huge formal floral gardens, fountains, a Greek amphitheater and bronze statues along with tremendous views from the Colorado State Capitol. Or stop by the Denver Art Museum and examine the 30,000 art objects including a collection of Native American art. The Colorado History Museum delivers the story of gold miners, cowboys, sodbusters, railroaders, soldiers and explorers who have shaped Colorado's history.

#### ***Shop at 16th Street Mall***

Littered with outdoor cafes, shops, fountains and beautiful flowers, the mall is the perfect place to pick up gifts for family and friends. The Denver Pavilions, a two-square block entertainment complex, showcases a variety of stores including a Hard Rock Café, Virgin Records Megastore, Nike Town, and 15-screen movie theatres. You can also catch a show at the Denver Performing Arts Complex, which offers everything from opera and symphony to Tony Award winning theatre.

#### ***Catch the nightlife at LoDo***

The city's historic district LoDo, short for Lower Downtown, is filled with a variety of pubs and fine dining establishments. Take a horse-drawn carriage or human pedaled pedicab through the district and enjoy a meal or glass of Denver brewed beer. There are also several jazz clubs and 30 art galleries along with a multitude of shops.

#### ***Family fun in South Platte Valley***

Lined with bike paths and parks, the scenic South Platte River also offers white water rafting and kayaking. America's only downtown theme park, Six Flags Elitch Gardens Amusement Park, has 48 thrill rides and a water theme park for the kids.

Hannu Kalimo and Matti Haltia, will emphasize molecular, cell biological and transgenic approaches to the study of neurological diseases and new applications in diagnostic neuropathology. The meeting will take place in the Helsinki Biomedicum, the new biomedical research center of the University of Helsinki.
