ANNUAL MEETING - ORLANDO 2003

The 79th Annual Meeting of the American Association of Neuropathologists will be held June 19-22, 2003, at the Wyndham Orlando Resort, located on the famous International Drive near Florida's most popular theme parks and downtown Orlando. On Thursday, June 19, a Special Course, *Magnetic Resonance Imaging of Neurological Disease*, will be held. The remainder of the meeting will consist of symposia and platform and poster scientific sessions. Meeting abstracts will be published in the May, 2003 issue of the Journal of Neuropathology and Experimental Neurology.

ORLANDO 2003 ANNUAL MEETING

PowerPoint Presentations

At the Denver meeting last June, approximately 80 - 85% of all presentations were done using PowerPoint. This year, presenters at **all** educational and scientific sessions again will have the option of using either computer (PowerPoint) or conventional 35mm slides. The trend is towards computer presentation is undeniable and this may be the last year that both presentation options are offered. Single-screen computer projection, and all computer equipment used during the meeting will be provided. Show computers will be equipped with Microsoft PowerPoint software for PC/Windows and Mac.

Presenters are asked to bring their presentation on either a PC or Mac-formatted Zip disk or CD-ROM, as well as their laptops as backup. Our audiovisual provider will supply *show* computers loaded with MS Office 2000 that will run from the podium, as well as Zip and CD-ROM drives. Presenters must bring their presentations on CD-ROM or Zip disk to the appropriate rooms prior to their presentation times. A schedule for loading presentations will be available in the information sent prior to the meeting.

Special Lecture

The Special Lectures introduced at the Denver meeting last year proved very popular and this year's selection will continue in that spirit. Dr. Robert D. Terry will present a Special Lecture, *AANP: The Earlier Days 1955-80*, that no doubt will provide valuable insights and vignettes of the history and people who played formative roles in our organization.

Program Update

Electronic submission of abstracts again has met with enthusiastic approval of members. All of the 182

abstracts received this year were submitted electronically. The Program Committee is reviewing the submitted abstracts and assembling what promises to be an exciting scientific program. Two platform sessions will be conducted concurrently and there will be *one* poster session each day. Abstracts will be published in the May 2003 issue of the *Journal of Neuropathology and Experimental Neurology* and the program will be posted on the AANP website by late March - early April.

Saul R. Korey Lecture: *Pathology and Pathogenesis in Multiple Sclerosis*, Dr. Samuel K. Ludwin (Sat, June 21)

Dr. Samuel K. Ludwin, Queen's University, Kingston, ON, and President of the International Society of Neuropathology has been selected as the 2003 **Saul R. Korey** lecturer. Dr. Ludwin's lecture entitled *Pathology and Pathogenesis in Multiple Sclerosis* promises to provide an insightful review of the "Greatcrippler of young adults."

Presidential Symposium: *Positron Emission Tomography in the Study of Neurological Disease* (Sun, June 22)

President Wiley has organized a symposium focusing on the application of PET in neurological disease. The program will include lectures on the *Physics and Principles of PET in the study of neurological disease*, by Dr. Bradley T. Christian (Wright State Univ Sch Med), and *FDG PET and the Nervous System*, by Dr. Robert Kessler (Vanderbilt Univ Med Ctr). As part of the Symposium, Dr. Carolyn Meltzer (Univ Pittsburgh Med Ctr) will present the **Matthew T. Moore Distinguished Lecture**, *Future of PET in the Study of Neurological Disease*. The program will conclude with Dr. Wiley's Presidential Address, *Kinetics of Macrophage Involvement in Neurodegeneration*.
